

How to [apply Vietnam visa](#)

Getting a visa is the first thing to do when you plan to travel or to do business in Vietnam. You can obtain your Vietnam tourist visa or Business visa by having a valid passport stamped prior to your departure by applying to any one of the Vietnam Embassies and/or Consulates in your country and worldwide.

However, if your particular city does not have a Vietnamese embassy, and you wish to avoid procedural delays (6 to 12 days), we can make this requirement a fairly easy exercise. You can submit information directly on our website or download word document, fill out and return to us with the required information by email.

We will then arrange to obtain the Vietnam visa approval code or visa approval letter for you just from 2 hours. You can bring the visa approval letter with you to get your visa stamped at any arrival airports in Vietnam (It is recommended for who travel to Vietnam by air).

With the Visa approval code you can bring it to the Vietnam Embassy in your Country to get your visa stamped (It is recommended to who arrive in Vietnam by Land or Boat).

4 steps to get [Vietnam visa on arrival](#)

Step 1: Fill out the secure online application form You are required to enter the exact personal information of the applicant(s). If you don't want to apply online you can download the word document form to fill in and send to us by email:

- Number of visa
- Type of visa
- Purpose of visit
- Kind of service : (single – exit and enter one time) or (multiple – exit and enter Vietnam more than one time) (during your chosen time).
- Date of arrival
- Port of arrival: Noi Bai airport (Hanoi), Tan Son Nhat airport (Ho Chi Minh City) or Danang airport or other international airports in Vietnam (to pick up your visa).
- Full name (as in passport)
- Passport number (valid at least six months)
- Passport Expiration Date
- Nationality
- Date of birth
- Gender

Rush services: Urgent (2 – 24 hours to process your visa approval letter) or Normal (2-3 working-days to process visa approval letter).

Step 2: Confirm and pay for Vietnam visa service fee after you complete and send us your visa application form, and pay the service fee, we will send an email to you confirming that we have received your request. Please send us a copy of your passport for double checking your information to make sure everything correct (mistake in just one character can cause you trouble getting your visa at the airport). You can scan your passport by a scanner or use your camera, mobile phone, ipad to take a picture of your passport and send to us by email sales@getvietnamvisa.com. After double check your information, we send it to Vietnam Immigration Department to process your visa promptly.

Step 3: Get Vietnam visa approval letter and prepare for getting visa stamped on arrival After 1 working day (urgent service) or 3 working-days (normal one), you will:

- Get visa approval letter via email (attached with entry and exit form)
- Print out the letter and the entry and exit form
- Fill out the entry and exit form
- Prepare 2 passport sized photos and an amount of USD for stamping fee (\$25 for single entry; \$45 for multiple entry visa less than 1 month and \$65 for multiple entry visa more than 1 month)
- Put all above mentioned things along with your passport in a package, then show them to Immigration officer at Vietnam arrival airports.

Step 4: Get your visa stamped (glued stamp on your passport) Upon arrival to Vietnam International Airports (Hanoi, Ho Chi Minh City, Da Nang, Nha Trang, Phu Quoc), you present all things in the prepared package (passport, visa approval letter, 2 passport sized photos, the exit and entry form and stamping fee) to the Immigration officer to get your visa stamped. We offer also Assistant Service (Fee \$25) to save your time waiting in a queue at immigration checkpoint at Vietnam Airports. Our staff will take care of every procedure right upon your arrival until your acquirement of stamped Vietnam visa.)

Note: Stamp fee is paid directly at airport but not our service fee. Please remember to bring along 2 photos. Following is the list of regulations regarding passport-style photographs:

- Photographs must be 2x2 inches in size, identical, taken within the past six months.
- The image size from the bottom of the chin to the top of the head should be between 1 inch and 1 3/8 inches.
- The photographs may be in color or black and white.
- They must be full face, front view with a plain white or off-white background.
- Photographs should be taken in normal street attire, without a hat or headgear that obscures the hair or hairline.
- Uniforms should be worn in photographs with the exception of religious attire which is worn daily.
- If prescription glasses, a hearing device, wig or similar articles are normally and consistently worn, they should be worn when the picture is taken.
- Dark glasses or nonprescription glasses with tinted lenses are not acceptable unless required for medical reasons. A medical certificate may be required to support the wearing of such glasses in the photographs.
